## <u>Annual Trash Day</u>

The annual trash clean-up will be held on Saturday August 17<sup>th</sup>, 2019 from 8:00am to 12:00 noon beside the Luther Newkirk Hall. Please bring your tax bill or receipt for township or village resident identification purposes. **Be prepared to unload your vehicle.** (Volunteers to help unload trash are always welcome.). **Accepted Items:** Scrap Iron, **Empty** burn barrels, Refrigeration units with Freon already removed, Auto Batteries, Open paint cans with dried up paints, and **Items must be Bagged, Bundled or Boxed**. **Items Not Accepted:** Tires, Chemicals, hazardous waste, motor oil, liquid paint, paint thinners, yard waste and household trash, unbundled shingles. Trailers or vehicles with scrap building materials. **If there is a line, please try not to block entrances to businesses or property owner's driveways.**

### <u>Tax Payments</u>

Summer Tax Payments are payable July 1<sup>st</sup>, 2019 and due by September 16<sup>th</sup>, 2019 without penalty, 1% penalty added starting September 17, 2019 and 1% per month until paid up to February 14<sup>th</sup>, 2020. Winter Tax Payments are payable December 1<sup>st</sup>, 2019 and due by February 14<sup>th</sup>, 2020 without penalty, beginning with February 15, 2020 please add 3%, penalty, **postmarks are not honored**. The Treasurer Betty Alward will be available at the Township Hall to collect taxes on: **Monday, March 2, 2020** from **9am – 12pm and 1pm-5pm** This is the last day to pay before taxes are turned in Delinquent on March 1<sup>st</sup>, 2019. **March 3rd, 2020 and after please pay Lake County Treasurer @ 800 E Tenth St. Ste. 210, Baldwin MI 49304.**
