Total of all accounts \$531,814.05. A motion was made by Carlson, 2<sup>nd</sup> by Chachulski to approve the financial statement as presented. –Roll Call Vote- Yes-Carlson, Chachulski, Pendley, Dean –No- None. All in favor. Motion carried.

Bills-Consumers Energy \$39.41; Verizon \$170.98; Summit Digital \$150.00; KT Moore Lawn & Snow \$1,250.00; Lake County Road Commission \$7,778.32; USPS \$80.80; Amazon \$154.79; Newkirk Township \$4,683.16; Lake County Treasurer \$13.55. Chachulski made a motion to pay the bills except to Newkirk contingent on the amount of scrap returned, 2<sup>nd</sup> by Pendley –Roll Call Vote- Yes- Chachulski, Pendley, Carlson, Dean. –No- None. All in Favor. Motion Carried.

Dean is going to contact more companies about the cemetery roads.

The council is going to contact different tree companies about the big pine trees at Pleasant Hill Cemetery. Some of the big trees are dying and we need to get a plan together.
